September 16, 2022, SINGAPORE – The American Chamber of Commerce in Singapore (AmCham) released the findings of an important study undertaken by BowerGroupAsia (BGA) to identify key recommendations to promote cooperation and collaboration under the auspices of the United States (U.S.)-Singapore Partnership for Growth and Innovation (PGI).
